Minutes of the 51st Meeting of the Board of Governors held on June 24, 2020

The Board of Governors, 51st meeting of National Institute of Technology Agartala was held on June 24, 2020 at 11:45 am in the Virtual Class Room, NIT Agartala, Tripura.

Prof. (Dr.) H. K. Sharma, Chairperson, Board of Governors and Director of NIT Agartala presided over the meeting and welcomed all members of the Board of Governors. The Chairperson also delivered his best wishes to stay safe during the COVID-19 pandemic situation.

The Chairperson invited the Registrar to initiate discussions on Agenda items.

<u>Item No. 51.1:</u> Confirmation of the Minutes of 50th Meeting of Board of Governors, NIT Agartala.

The minutes of 50th Meeting of the Board of Governors held on January 21, 2020 were confirmed.

Item No. 51.2: To consider the visit of National Board of Accreditation (NBA).

The Board noted the information and appreciated the efforts of the Director, NIT Agartala.

Item No. 51.3: To consider draft MoA between ILS Hospital and NIT Agartala.

The Board approved the proposal for signing the MoA between ILS Hospital and NIT Agartala as per CS MA rules.

Item No. 51.4: Service matter of Shri Sumanta Chakraborty, Ex-Dy. Registrar in connection with case filed by him vide case number W.P. (C) 1298/2017, pending before the Hon'ble High Court of Tripura.

Shri Sumanta Chakrabarti joined NIT Agartala on 12.08.2011 as Deputy Registrar vide appointment letter no. F.NITA.2(166-Estt)/11/2478-82, dated 21st July 2011 from Tripura State Pollution Control Board (A Govt. of Tripura Organization). As per terms and conditions of appointment letter vide clause no.11 (Retirement Benefits) states that "the Institute has the New Pension Scheme (NPS), Govt. of India for the employees joining after 01.04.2004. For in service candidates appointment under the Institute will be duly supported with pay protection and will be governed by Rules as defined in the FRSR", which was accepted by Shri. Chakrabarti while joining at NIT Agartala. The LPC (Last Pay Certificate) dated 11.08.2011 submitted to NITA by Tripura State Pollution Control Board (TSPCB) (his previous organization), indicated that he was subscribed to EPF vide EPF Account No. AS/TR/2205/10 which was being maintained by the Commissioner, Employee Provident Fund Organisation, Bholagiri, Agartala, Tripura (Copy enclosed). But somehow, his service condition was changed to GPF, which violates the rules/provisions of NITSER Act & Statutes and Govt. of India and also the terms and conditions of above mentioned appointment letter.

Based on the facts, Board decided that

- (a) Shri Sumanta Chakraorti, who joined NIT Agartala on 12-08-2011 can not be granted the benefit of GPF as per the Clause 29 of NIT Statutes and appointment letter because he did not have GPF in his previous service at the time of joining at NIT Agartala.
- (b) Board decided to keep the actions on hold till the verdict of Hon'ble High Court of Tripura (W.P (c) 1298/2017).

The above decisions are taken subject to the verdict of the Writ Petition (C) 1298/2017 filed in the Hon'ble High Court of Tripura.

Item No. 51.5: To consider nomination of members to Board of Governors (BoG), Finance Committee (FC) and Building & Works Committee (BWC) of NIT Agartala.

The Board ratified the nomination of Dr. Debasish Bhattacharya, Professor, Mathematics Department, NIT Agartala as the Member of Board of Governors and Finance Committee of NIT Agartala. The Board also ratified the nomination of Dr. S. K. Pal, Professor, Civil



Engineering Department, NIT Agartala as the Member of Building & Works Committee of NIT Agartala.

Item No. 51.6: To consider the recommendation of the minutes of 34th Finance Committee meeting of NIT Agartala held on October 03, 2019.

The Board approved the recommendation of the 34th Finance Committee meeting of NIT Agartala.

Item No. 51.7: To consider the Annual Budget proposal of the Institute for the Financial Year 2020-21.

The Board ratified the decision of Chairperson, BoG with regard to Annual Budget proposal of the Institute for the Financial Year 2020-21, subject to the availability of resources. The issue—with regard to delegation of power was raised by one of the member. NIT Agartala will look at NITSER Act & Statutes and accordingly the matter will be apprised to the Board

Item No. 51.8: To consider re-employment of faculty members after superannuation.

The board decided to give superannuation on the specified date. After superannuation contractual extension can be given till the end of the semester. The pay will be fixed after subtracting the pension. The Chairperson, BoG will give extension on merit.

Item No. 51.9: To consider the issue pertaining to the ongoing TEQIP-III programme at NIT Agartala: Procurement plan of TEQIP.

The 5th Phase Procurement Plan of Rs. 29,50,000.00 (Rupees twenty nine lakh fifty thousand) only under TEQIP-III, NIT Agartala has been approved by the Board as per TEQIP rules.

<u>Item No. 51.10:</u> To consider the superannuation of employees of NIT Agartala during two years.

A draft letter, seeking the directives from MHRD is approved. The ADG (HE), MHRD was appealed to take up the matter at an appropriate level to resolve the issue. The Cheques, returned may be deposited in bank for the time being and the request of the Registrar to withdraw his GPF may be dealt as per rules. The Registrar did not participate in the discussion and isolated himself.

Item No. 51.16: Consolidated salary to the contractual faculty of NIT Agartala having Ph.D degree.

A consolidated salary (fixed) of Rs. 70,000/- is approved to the contractual faculty having Ph.D. degree. The Board suggested to explore other cases also to grant consolidated salary. It suppresses earlier agenda with regard to increment for the contractual faculty.
