Mr. Dipak Ch. Das, Chief Engineer, PWD (R&B), Govt. of Tripura and the Secretary, Department of Higher Education, Govt. of Tripura could not attend the meeting.

Prof. (Dr.) H. K. Sharma, Chairperson, Board of Governors of NIT Agartala presided over the meeting and welcomed all members of the Board of Governors. The Chairperson then invited the Registrar (I/C) to initiate discussions on Agenda items.

Item No. 58.1: To consider the recommendation of Selection Committee for recruitment in the different post of Group-A level.

Interviews for 9 (nine) different categories post viz. Medical Officer, Assistant Engineer (SGII) (Civil/ Electrical Engineering), Executive Engineer (Civil Engineering), Scientific/ Technical Officer, Student Activity and Sports (SAS) Officer, Deputy Registrar, Deputy Librarian, Assistant Librarian and Assistant Registrar were conducted during 12<sup>th</sup> March, 2022 to 5<sup>th</sup> May 2022 in three phases. The recommendations of the Selection Committees for those posts were placed before the Board in sealed envelopes. With permission of the Board, the sealed envelopes

were opened and recommendations of the Selection Committees were placed before the Board for consideration and approval.

During the discussion it was mentioned that Recruitment Rules (RR) were followed and Reservation Rules have also been observed. Further for different small groups of posts, 14 point Reservation Roster, as per Govt. of India guidelines and Experts advice was prepared. The Board after discussion approved and confirmed the recommendations of the Selection Committees.

Item No. 58.2: To consider the Reservation in the Post of Associate Professor and Professor for direct recruitment at NITA.

NIT Agartala published rolling advertisement in its Website vide Notification No. F. NITA, 2 (521-ESTT)/ 2022/ Vol. III/ 734, dated: 22-04-2022 and No. F. NITA. 2 (545-ESTT)/ 2022/ 1/ 159, dated: 11-04-2022. The Last date of submission of online application form for the first cycle is 30th June, 2022. Already a good number of applications have been received. Now, due to the Implementation of Central Educational Institutions (Reservation in Teachers' Cadre) Act. 2019, a new reservation roster is to be prepared by the Institute following Government Policy. In this respect a committee constituted by the Institute prepared, a Cadre and Category wise distribution of the total sanctioned faculty positions (presently occupied posts and vacant posts) and the same was placed before the Board. The representatives from the Bureau of MoE and Integrated Finance Division (IFD) of the Ministry in principle accepted but suggested certain points to be looked at. After deliberation over those points in consultation with the experts, the committee members, prepared a modified self-explanatory cadre wise and category wise breakup of posts (Annexure - A), for kind consideration of the Board. During the confirmation of 58th BoG meeting minutes, the Board deliberated on the category wise and cadre wise breakup of the post and approved the same incompliance to the Central Educational Institutions (Reservation in Teachers' Cadre) Act, 2019.

Item No. 58.3: Demand Notice U/s 147 r.w.s 144 issued by the Income Tax Department for A.Y 2013-14 to 2017-18 against NIT Agartala amounting Rs. 39,49,64,310/-.

The matter was discussed elaborately and the Board decided that the matter to be defended while hiring a legal counsel and all the channels to be explored.
