Minutes of the 21st Meeting of the Board of Governors held on 9th February 2012

At Conference Room of NIT Transit House

The 21st meeting of the Board of Governors of the Institute was held on 9th February 2012 at 11:45 am in the Conference Room of NIT Transit House, Kunjaban, Agartala.

Prof. P. N. Singh, Chairman of the Board of Governors (BOG) welcomed all the members. He briefed the members of BOG regarding 4th Convocation to be held on 10th February, 2012 and appreciated the efforts made by faculty members for organizing the Convocation in a short notice. The Chairman then requested the Director and Registrar to initiate the discussion on agenda items.

Prof. P. K. Bose, while welcoming the members, informed the BOG that the main Agenda of 21st meeting was to consider holding of Convocation and conferment of Honoris Causa — Doctor of Science to Padma Bhushan Prof. U. R. Rao, former Chairman, Indian Space Research Organization (ISRO), in addition to other items. The Director mentioned that Sri Kapil Sibal, Hon'ble Minister of Human Resource Development and Communication & Information Technology, Govt. of India will be the Chief Guest in the Convocation. He also pointed out that Sri Badal Chowdhury, the

Dr. N. K. Kole, Registrar then presented the Agenda Items for discussion and decision by the Board.

<u>Item No. 21.1:</u> Confirmation of the Minutes of Twentieth Board of Governors Meeting.

The minutes of the twentieth Board of Governors meeting of NIT Agartala, held on 7th January, 2012 were confirmed.

Item No. 21.2: To consider the recommendations of the 10th SENATE Meeting held on 9th February 2012 at 10:30 am in the Conference Room of NIT Transit House.

The BOG noted that the 10th Senate meeting was held at 10:30 am just before holding the 21st BOG meeting on the same day due to extreme urgency. The Board also noted that there were six agenda items and the minutes of 10th Senate meeting were placed on the table.

While accepting the recommendations of 10th Senate meeting, the Board decided to include the following information for record.

- i) The BOG approved awarding of Ph. D. degree in Engineering to Smt. Sima Ghosh, a Ph. D. Scholar in Civil Engineering Department of NIT, Agartala for Ph. D. topic "Seismic Response and Stability of Retaining Wall Supporting Ø and c- Ø Backfill" under the supervision of Dr. R. P. Sharma, Professor of Civil Engineering and Dean (Academic Affairs), NIT Agartala.
- ii) BOG approved starting of MBA programme in NIT, Agartala from the academic session 2012-13 with an intake capacity of 30, subject to the condition that the syllabus is finalized with the help of experts before starting the programme.
- iii) Regarding MoU to be signed between NIT, Manipur and NIT, Agartala for collaborative Ph. D programme to benefit the faculty members of NIT Manipur, the BOG approved the proposal for signing the same in line with the relevant provision of existing MoU signed between IIT Guwahati and NIT Agartala with the modification that NIT Agartala will award Ph. D degrees to the faculty members of NIT Manipur, without compromising with the requirements for the award of Ph. D degree.

- (a) The BOG ratified the decision of its Chairman regarding inclusion of the following experts in the panel for selection (Interview Committee) of faculty members.

The recommendations made by the Committees (Interview Committees) were placed before the Board after opening the sealed envelopes during the meeting.
