The minutes of 60<sup>th</sup>, 61<sup>st</sup> and 61<sup>st</sup>–A (Special) Board of Governors meetings were confirmed. The Board decided to drop the agenda (Item No. 60.6) and not to execute further as the fellowships are being paid by the Government of India.

  is pronounced. However, Institute can take action time to time on the receipt of courts
  order/verdict.

- IV) They will not be involved in any of the purchase or the affairs, where any monetary transaction is involved.
