 Shri Manish Kumar, Dy. Registrar, NIT Agartala who was on lien to National Law University, Delhi and tendered resigned from NIT Agartala w.e.f. 21<sup>st</sup> October 2024.

• Shri N. V. Siyakumar Hari, Assistant Registrar, NIT Agartala who was on lien to IIT Goa have been absorbed at IIT Goa and has vacated his lien at NIT Agartala.

As a result, one vacancy each has been created at the post of Dy. Registrar and Assistant Registrar.

The Director informed that only Direct Recruitment vacancies are being filled in this cycle, the other vacancy released from lien will be advertised soon.

Item No. 69.4: Consider newly engaged contractual non-teaching staff of NIT Agartala on various positions.

The Board confirmed the engagement of the contractual employee(s) engaged and permitted engagement of employee(s) on contractual basis. These employees will be appointed in lieu of employees on contract who have completed 70 years of age. Mr. N. S. Bisht, Dy. Secretary (IFD) communicated that age stipulation akin to govt. employee i.e. 65 years be followed.

Item No. 69.7:

The Board deliberated on the case of Dr. Govind Bhargava and perused the letter addressed to Dr. Govind Bhargava dated 09-01-2025. As the case of Dr. Govind Bhargava has already been addressed by 34<sup>th</sup> FC vide Item No. 34.7, 48<sup>th</sup> BoG vide Item No. 48.9 and 56<sup>th</sup> BoG vide Item No. 56.7.1 in past, the Board resolved to take no action as of now as no new inputs have been placed before the Board.

Item No. 69.8:

To consider change in terms of appointment and fixation of salary of Col. (Dr.) Ashish Badola, Registrar, NIT Agartala.

The Board examined the minutes of selection committee of the Registrar No NITA.2 (528-Estt)/2019 dated 20.08.2022 (copy enclosed as *Annexure - D*), the offer of appointment dated 14.10.2022 addressed to Col. (Dr.) Ashish Badola and as forwarded to Military Secretary Branch, IHQ of MoD (Army) vide NITA letter No F.NITA.2(609-Estt)/2022/L/8723-25 dated 03.11.2022 (copy enclosed as *Annexure - E*) and the report on performance of Registrar as placed by the Director (copy enclosed as *Annexure - F*). The Board resolved that the tenure as per offer letter is valid for a period of 5 years or 62 years whichever is earlier from the date of appointment of Col. (Dr.) Ashish Badola.

The Military Secretary Branch, IHQ of MoD (Army) letter No A/12071/NIT/52643/2024/MS-3B dated 09 Oct 2024 (copy enclosed as *Annexure - G*) has extended the tenure of Col. (Dr.) Ashish Badola till 31 May 2025 in order to superannuate in-situ thereby indicating that there in no gap in service being rendered in NITA.

The Board further resolved that pay fixation of Col. (Dr.) Ashish Badola be carried out as per reemployment norms (pay with adjustment of pension) as he is superannuating from government service (Central government- Indian Armed Forces).

Col. (Dr.) Ashish Badola did not participate in the discussion and had been requested to vacate the meeting.

Prof. Swapan Bhaumik, member BoG raised observation during the meeting on the legality in the method of extension of tenure of Col. (Dr.) Ashish Badola followed by a mail dated 30 May 2025 addressed to Chairman BoG and copy to members of BoG (less Secretary). The matter was examined in the light of documents placed before the Board, the retention of Col. (Dr.) Ashish Badola is valid for the reasons as under:-

- (a) The minutes of selection committee clearly indicates the terms and conditions of the service. The "Remarks" of the selection committee confirms that the committee were well aware of the aspect of superannuation and as it was conforming to the relevant policy provisions of DOPT, therefore the tenure of 05 years was accordingly offered to Col. (Dr.) Ashish Badola. Moreover, numerous judgement of Supreme Court of India also states that the directions of selection committee duly constituted as per laid down Act and Statutes cannot be questioned/challenged.
- (b) The offer of appointment clearly states the tenure and its continuation after the date of superannuation from Indian Armed Forces (with effect from 31 May 25). The service by Col. (Dr.) Ashish Badola has to be continued as per the offer of appointment. The terms



and conditions cannot be questioned or reviewed after joining moreover after completion of part of the tenure.

- (c) There is no suppression of facts by Col. (Dr.) Ashish Badola on the service conditions.
- (d) The decision of one BoG cannot be reversed by subsequent BoG until unless any evidence of any malafide intention is placed before BoG to review earlier decision. In the instant case no such case has been brought by Prof. Swapan Bhaumik before the Board.
- Item No. 69.9:

  To consider creation of a separate Department viz. Department of Education on implementation of ITEP in B. Sc.-B. Ed. Programme at NIT Agartala.

The Board noted the proposal. The Director informed the Board that the creation of a separate department is for administrative reasons and a regular faculty member of NITA has been entrusted with the responsibility of HoD. The faculty for the department is being engaged as guest faculty with consolidated pay on semester basis.

A. 209 of 2021 filed by The Union of India and 4 Ors. - Vs. Shril Sumanta Chakraborty. Before the Hon'ble Division Bench, High Court of Tripura at Agartala.

Sir.

I have gone through the judgment & order dated 02.08.2023 passed by the Hon ble High Count of Tripura, Agartala and entire case records in connection with the above mentioned case. On perusal same, I find that, the Honble Division Bench by its order dated 02.08.2023 is pleased to upfield the judgment and order dated 31.03.2021 and order of correction dated 21.06.2021 passed by the learned single judge in W. P. (C) No. 1298 of 2017 and accordingly dismissed the instant writ appear. ## District & Subordinate Courts in the country except at Delhi, Mumbal. Kolkata, Chennal & Bengaluru:

For District & Subordinate Courts in the country, except at Delhi, Mumbal, Kolkata, Chennai & Bengaluru, the concerned Standing Government Counsel (SGC) is the In-charge litigation who is entrusted with the task of allocation of cases amongst the other panel counsel for the concerned District & Subordinate Courts, i.e. Additional Standing Govt Counsel (including the SGC)

- 5. All the Departments / subordinate offices of the Central Government are required to directly contact the Litigation Incharge of the concerned court / tribunal as detailed in para 4 (A) to (C) above, for the engagement of counsel / change of counsel (if required) from the panel for that court / tribunal to represent Union of India in their cases. The contact details of the concerned ASGI / Asst. SGI / Sr. CGSC/ SGC / Incharge of Litigation Sections & Branch Secretariats are available on the official website of this Department Departments / subordinate offices of Central Government are advised to ensure from time to time that the panel counsel who is representing them is still on the panel of this Ministry. If the tenure of representing panel counsel expires before disposal of the case, the concerned Litigation Incharge may be approached for the engagement of another counsel from the panel. All the Ministries / Departments are advised not to engage counsel who are not on the panel of this Ministry/Department without approval of this Department.
- 6. In addition to the above, in this context, Item No. 9 (i) of the Annexure to Schedule V of the Delegation of Financial Power Rules (DFPR), 1978 is also referred which clearly establishes the principle for the expenditure on account of Legal Charges which needs to be paid to all kinds of Barristers, Advocates, Arbitrators, Pleaders and Umpires representing. Union of India before any court (including tribunals) in the country only with the prior consent of this Ministry, and, in case of Law Officers/panel counsel engaged by this Ministry, Legal Charges are to be paid as per the fee schedule prescribed by this Department for the purpose.
- In light of the above, engagement of counsel to represent Union of India before any court / tribunal of the country, who are not on the panel of Ministry of Law & Justice with running tenure and / or whose engagement has not been approved by Ministry of Law & Justice, is violation of (i) the Government of India (Allocation of Business) Rules, 1961 and (ii) the Delegation of Financial Powers Rules, 1978.
- 8. All the OMs of this Department referred above. Details of concerned Litigation Incharges and details of Panel Counsel (in the form of orders of empanelment) are available on official website of this Department i.e. www.legalaffairs.gov.in.
