The Building & Works Committee (BWC) ratified the action taken in awarding works mentioned in the respective items under agenda item No. 34 3.

Item No. 34.4: To consider the estimate for "Construction of Central Lecture Hall Complex having 27 Class Rooms at NIT Agartala" at a cost of Rs.70,52,95,723.00.

The Building & Works Committee was apprised about the proposal. BWC noted that the meeting of the Scrutiny Committee comprising of the experts Dr. Virendra Kumar Paul and Dr Lakshman Nandagiri has been scheduled to be held on 16th September 2015.

Item No. 34.5: To consider the total tentative deviation (including extra items, substitute items etc. in totality) in the work of Construction of Sports Complex at NIT Agartala at a cost of Rs. 4, 87,99,551.00.

This item was discussed in details and it was opined that more information regarding the amount of deviated structural steel/ polycarbonate/ reinforcement steel, RCC & brick work, the rate in excess of 30% is to be decided by the Institute after discussion with the contractor. After this exercise, special meeting may be convened to discuss regarding this agenda item M/S NCC Limited to be communicated for holding discussion regarding negotiation of rate in respect of structural steel, polycarbonate sheet, reinforcement, brick work & RCC, for the amount in excess of 30% of the BOQ.
