<u>Item No. 35.1:</u> Confirmation of the Minutes of 34th Meeting of Finance Committee held on October 03, 2019.

The recommendations of 43rd Building & Works Committee meeting held on June 21, 2019 with regard to Item No. 43.15, 43.16, 43.18 and 43.24.1 were accepted and recommended to place it before the BoG.

Item No. 35.8: Adoption of the guidelines for settlement of claims for compensation as enunciated in various judgments of Hon'ble Supreme Court in case of death/ permanent incapacitation due to unintended/ unforessen occurrences during maintenance, operation and provisioning of public services.

The guidelines of DoT vide Memorandum No. 36-11/2015-SR, dated: 5th December, 2016 and Institute committee are approved. However, point no. 2 of the institute's committee report may be read as, the guidelines will be applicable for all employees who are not covered under Group Insurance. The superannuated employees from any sector will not be covered under this scheme.

Item No. 35.9: To consider GPF balance in respect of Dr. Vidyut Dey, Assistant Professor, Production Engineering Department.

The Finance Committee noted the proposal and suggested to recover the interest from Dr. Vidyut Dey during the period of withholding the amount/ fund.
