Furthermore her name is missing from the list of provisional shortlisted candidates published by the Institute though she applied within the stipulated deadline & fulfilled the eligible criteria	In the grievance mail, candidate registration no is wrong. The valid registration id is NITAGR2024/07/17809. The application is incomplete as the candidate's photo is missing and also the email id is invalid. Also, the candidate did not fulfil the educational qualification as mentioned in the advertisement which explicitly stated that "For the post of Scientific/Technical Officer. In the recruitment rules, the relevant fields include Computer Science and Engineering/MCA Degree" in point no 33 of the General Instruction and information section of the said advertisement. 02	NITAGR2024/07/17753	Candidate claims that he has received a notification that he was not shortlisted due to not fulfilling the age criteria and he stated that as a person with Disability (PwD) candidate, he is eligible for age relaxation as per the GOI rules.	As per the Recruitment Rules for the post of Scientific/Technical Officer age limit for direct recruits is 35 years. As per application the candidate is PWD Hence applicable age relaxation as per Central Government rules may be provided subject to original document verification	Provisionally Shortlisted
03	NITAGR2024/07/17988	Candidate claims that he fulfills both the essential & desirable qualifications as per the advertisement but he has not been shortlisted with a remark stating 'Not eligible due to not fulfilling requisite qualification'.
