The Ph.D candidates who cannot submit any required document such as Mark-sheet, Category Certificate, Migration Certificate etc. at the time of admission must submit the same within 30 (thirty) days from the last date of admission in Ph.D programme failing which the provisional admission shall stand cancelled automatically. The candidate will however be required to submit an undertaking to this effect at the time of admission.

• To upkeep the standard and quality of teaching it is not possible to impart teaching to 184 students with the existing infrastructure, lab facility and faculty strength.

- Adequate number of candidates have not been found in spite of several advertisements given in local and national dailies inviting applications for recruitment to the post of Assistant Professor/ Associate Professor/ Professor presently in the Civil Engineering Department.
- Presently Civil Engineering Department is running with only 29 faculty members where as the minimum requirement is 53 nos. of faculties. An institute of eminence cannot afford to dilute the quality of teaching.
- The members of SENATE opined that the Institute should not take the risk of enhancing of seat to 150. It is better to reduce it to 120 or in extreme case it may go up to 150 if situation demands.
