#### Item No. S/38/03

Consideration and approval of maximum time limit to be allowed to the Ph.D scholar for Comprehensive examination.

The SENATE approved that the maximum time limit to be allowed to the Ph.D scholar for Comprehensive examination for Full-time (with scholarship and self financed), Sponsored (full-time), Project Staff, QIP, Foreign Ph.D scholars will be before completion of 4<sup>th</sup> semester. It was also decided that for Part-time, External registration, Institute employee categories scholars, the limit will be before completion of 5<sup>th</sup> semester.

This will be effective from the admission batch 2022-23.

#### Item No. S/38/04

Consideration and approval regarding calculation of class load for faculty members having UG and PG project of students.

The SENATE approved and confirmed that the project and thesis of UG and PG students that are supervised by the faculty members will not be calculated as class load.

#### Item No. S/38/05

D thesis under supervisor(s), such date will be considered as a cut-off date to deduct the point(s) (1 or 2, whichever applicable) of the supervisor(s). The house also perused that such calculation will be beneficial on the part of the faculty members of the Institute.

Consideration and approval of introduction of Medical fee for Ph.D scholars in all ODD semesters.

The SENATE approved and confirmed that the Ph.D scholars to pay Medical fee in all their ODD semesters until the provisional Ph.D. thesis is submitted.
