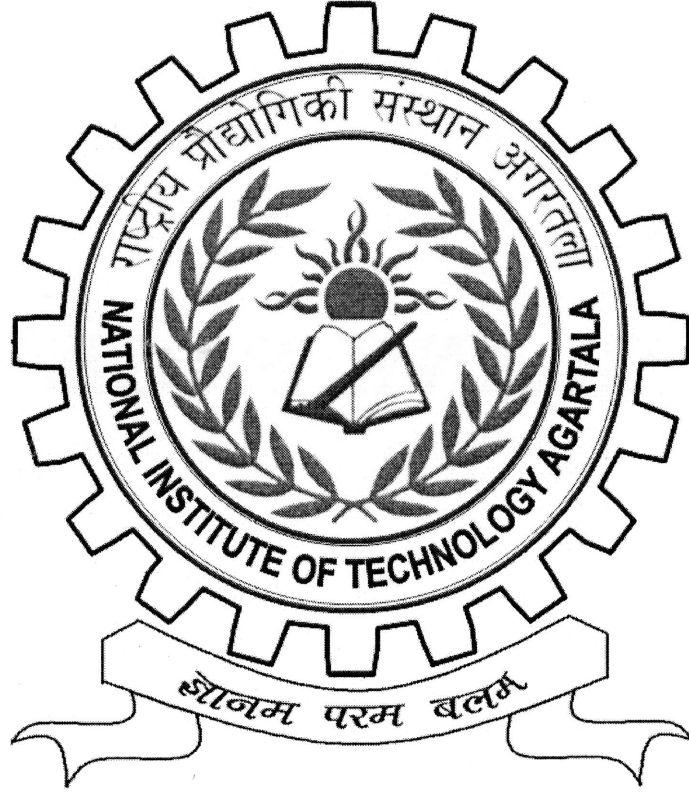

Consideration and approval of finalization of seat capacity, educational qualification and fee structure for the foreign candidates for admission at NIT Agartala in UG, PG and Ph.D programmes.

The SENATE approved and confirmed the proposal with the following:

1. Educational Qualification and minimum percentage required for applying:

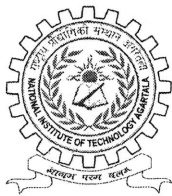
- B.Tech: Must have secured at least 75% marks in class XII Board examination with Physics, Chemistry and Mathematics as mandatory subjects.
- M.Tech: Must have secured at least 65% marks or 6.5 CGPA in 10 point scale in B.E/ B.Tech in relevant branch.
- Ph.D: Must have secured at least 65% marks or 6.5 CGPA in 10 point scale in M.E/ M.Tech in relevant branch.

➤ In all cases except B.Tech, the medium of instruction must be in English only or the proof of English proficiency such as IELTS/ TOEFL to be submitted.

➤ In case of admission in B.Tech programme, the applicants must have studied English as a subject from class 9th to 12th standard or equivalent:

2. No of Seats:

- B.Tech: 10 % supernumerary seats, department wise, for SII/ ICCR/ MEA.
- M.Tech: 10 % supernumerary seats, department wise, for SII/ ICCR/ MEA.


