In the clause 11.3, the mandatory subject 'Research and Publication Ethics' to be added with the existing Research Methodology subject.

The 'second attempt' mentioned in the clause no. 11.3 to 11.5 of Ph.D Regulations 2018 includes the supplementary examination of any subject in the coursework allotted by the DC.

The house approved that the Chairman of a particular DC cannot be any other member of that DC. This is to be implemented from 2021-22 academic session.
