The SENATE perused and accepted the action taken on the items

Item No. S/43/3 Consideration and approval of uniform academic Caution Money for all the courses/ programmes of NIT Agartala.

The SENATE approved and confirmed the uniform academic Caution Money for all the courses/ programmes of NIT Agartala @ Rs. 10,000/-

Item No. S/43/4 Consideration and approval of issuing Transfer and Character certificate to students who withdraw their admission before completion of the course.

The SENATE approved and confirmed the format of Transfer and Character certificate to students with minor modification and authorized the Chairman SENATE for finalizing the format.

Item No. S/43/5 Inclusion of T & P fee @ Rs. 2000/- for the students of BS-MS and other programmes.

The SENATE approved and confirmed the inclusion of T & P fee @ Rs. 2000/- for the students of UG, PG and Dual Degree programmes. For the Dual Degree programmes, such fee will be levied during 9th and 10th semester and students will be allowed to appear in the placement activities during the 5th year of the programme. Such fee will not be applicable for the Ph.D scholars.

It will take effect from the admission batches of 2024-25.

Item No. S/43/6 Consideration and approval of pursuing research work by the Ph.D scholar in any other Institute/ organization with applicable scholarship and without taking any leave.

The SENATE approved and confirmed the following regarding pursuing research work by the Ph.D scholar in any other Institute/ organization with applicable scholarship and without taking any leave:

- (i) Proposal to be initiated by the concerned supervisor(s) and Dean (AA) may approve such proposal upon recommendation by the respective HoD. Dean (AA) may approve such proposal if the duration of research work outside Institute is less than 6 months. For cases beyond 6 months, the approving authority will be the Director.
- (ii) If any scholar requires visiting outside India, in such cases also the approving authority will be the Director.
- (iii) Ph.D scholars may be allowed for a maximum period of 6 months, preferably during the vacation period of the Institute, throughout the entire duration of Ph.D programme.

The house also approved the following:

- a. If a scholar has Joint-supervisor in the Institute/ organization where he/ she pursue some portion of research work, the attendance will be maintained by the Joint-supervisor and report to be sent to the Supervisor (at NITA). Based on the report, Supervisor to recommend for the monthly scholarship/ fellowship of the scholar.
- b. If a scholar does not have Joint-supervisor in the Institute/ organization where he/ she pursue some portion of research work, the scholar may be allowed to pursue his/her research work for not more than 6 months in 'On- duty leave' from the date of joining. In such cases, monthly scholarship/ fellowship of the scholar will be recommended by the Supervisor solely.

The SENATE approved and confirmed the following in respect to the credit requirement of course work for scholars who are admitted in the Ph.D programme in engineering Departments with a B.Tech/B.E/B.Pharm, or Master of Science (M.Sc.) degree:

- Clause 11.4: The GATE qualified fresh B.Tech candidates will have to complete the course works of at least 24 credits in addition to compulsory courses (Research Methodology; Research & Publication Ethics; Intellectual Property Rights and courses as and when applicable).
- Clause 11.5: The candidate who has Master Degree in Science but would like to register for Ph.D. in Engineering/Technology Discipline will have to complete at least 24 credits in addition to compulsory courses (Research Methodology; Research & Publication Ethics; Intellectual Property Rights and courses as and when applicable).

The house also suggested for issuing a notice and amend the Institute Ph.D Regulations accordingly.

The Dean (Academic Affairs) will nominate the 1st year Coordinator for 2 (two) years and 2 (two) Co-coordinators for same with 2 two years duration. After completion of 2 (two) years, the Co- coordinator (the senior among the two Co- coordinators) will take the charge of Coordinator and Dean (AA) will nominate a new Co- coordinator for 1st year students and it will continue. The same will be included in the Regulation of the Institute.

Item No. S/43/11 Consideration and approval of submission of modified Ph.D thesis by the scholars on the report(s) of the examiner(s).

The SENATE approved and confirmed the submission of modified Ph.D thesis by the scholars on the report(s) of the examiner(s) with the following suggestions:

- If the examiner(s) give the major modification on the Ph.D thesis (OPTION-3 in Ph.D form no. 14 (A)), the modified thesis shall be submitted by the scholar within a maximum period of 3 (three) months from the date of sending the report to the Chairman DC.
- If the examiner(s) give the major modification on the Ph.D thesis (OPTION -4 in Ph.D form no. 14 (A)); the modified thesis shall be submitted by the scholar within a maximum period of 6 (six) months from the date of sending the report to the Chairman DC.
- If the scholar requires more than 6 month, in that case the DC has to recommend for allowing more time to the scholar with proper justification, for approval of the Chairman SENATE through Dean(AA).

This will take immediate effect.

Item No. S/43/12 Consideration and approval of change of coursework subject of the Ph.D scholar, at a later stage.

The SENATE approved and confirmed the following:

If a scholar secures 'F' grade in any course of coursework from MOOCs, such scholar is allowed to replace the previous course by another coursework from the MOOCs or any course offered by the Department. Such cases will be treated as second attempt in respect of that course work.

Item No. S/43/13 **Consideration and approval of providing Scholarship from Ministry of Education (MoE) (erstwhile MHRD) to the UGC-NET/GATE qualified students under the Department of Management, Humanities and Social Sciences (MHSS).**

The SENATE perused that MoE scholarship are being given in other Institutes of National Importance to the UGC-NET/GATE qualified students who take admission in the Ph.D programme with M.A/ M.Com etc., degrees being reported by the committee constituted for the purpose. Viewing to this the house approved and conformed that MOE fellowship can be given to candidates of MHSS Department of the Institute admitted in the Ph.D programme with preceding Master degree in MA/ M.Com etc. with NET/ GATE qualification obtained in some point of time in the past.

This will be applicable for all the scholars of MHSS Department and will be effective from 01/07/2023 at rates applicable, upon approval of the FC and BoG.

Item No. S/43/14 **Consideration and approval of minor amendment in the Clause No 7.1 of the Existing Ph.D. Rules 2018 of NIT Agartala to become a Supervisor(s)/ Co-/Joint- supervisor (s) for the Department of Management, Humanities and Social Sciences (MHSS).**

The house perused the existing clause 7.1 of the Ph.D Regulations 2018 regarding supervisorship of Ph.D scholars and resolved that the clause 7.1 is required to be amended. The SENATE approved and confirmed the following:

“A regular/permanent faculty of NIT Agartala who is a Professor/Associate Professor/ Assistant Professor with a doctoral degree will be recognized as a Supervisor. A Supervisor should have published 3 SCI/ SSCI journals/ Granted Patents to be eligible to supervise his/ her first scholar at NIT Agartala. The regular/permanent faculty members of MHSS Department (HSS and Management) should have published 3 articles in SCOPUS indexed journals (Q1 & Q2 only) to be eligible to supervise his/ her first scholar at NIT Agartala.”

Subsequently, the house also approved and confirmed that the eligibility criteria as mentioned in amended clause 7.1 will be applicable for Co-/ Joint-Supervisorship also.

This will take an immediate effect.

Item No. S/43/15 **Proposal of revision of selection criteria in Ph.D. programme for candidates with M. Tech degree.**

The SENATE approved and confirmed the following for candidates with Master's degree for admission in Ph.D programme in Engineering Departments:

- i. Master's Degree in Engineering/ Technology or equivalent in an appropriate area with a minimum CGPA of 6.5 out of 10 point

- ii. Master's Degree in relevant science discipline with a good academic record and of exceptional merit are eligible for relevant engineering discipline with minimum CGPA of 6.5 out of 10 point grading system or more or at least 60% of marks, from a recognized Institute or University.

Item No. S/43/16 Consideration and approval of M. Sc. in Science as an eligible degree for admission to M. Tech in Chemical Engineering at NIT Agartala.

The SENATE suggested to constitute a committee with the following members regarding inclusion of M. Sc degree in Science as an eligible degree for admission to M. Tech in Chemical Engineering at NIT Agartala. The will also be responsible for recommendation of all cases of proposal from Departments regarding inclusion of eligible degree for admission to M.Tech/ M.Sc programmes of the Institute.

The SENATE suggested that all the supervisors / Co-Jt. Supervisors must have the minimum criteria for supervising the scholar as per existing criteria of NIT Agartala.

Item No. S/43/27 **Clarification on implementation of item no. S/41/24 regarding count of points for guiding Ph.D scholar.**

The SENATE decided that calculation of point vide item no. S/41/24 of 41st SENATE meeting will take retrospective effect.

Item No. S/43/28 **Consideration and ratification of the results of the Odd semester.**

The SENATE ratified and confirmed the result of all courses of Odd semester was published on 08/12/2023 and 05/01/2024.

The house suggested that Institute MIS to give more detailed analyses of the results.

Item No. S/43/29 **Consideration and ratification of enhanced seats of MCA programme.**

The SENATE ratified and confirmed enhanced number of seats for the MCA programme. The intake will be 60 from the academic year 2024-25.

Item No. S/43/30 **Consideration and ratification of admission in B.Tech programme through Study In India (SII).**

The SENATE was acknowledged the admission of the first admitted foreign student at NITA through SII scheme of GoI. The house also ratified and confirmed the admission of the student Mohammad Tanjeem Javed (Enrollment No. 23UCS212) in B.Tech programme through Study In India (SII) during 2023-24 academic year, including remission in tuition fee of 33.33% and other fee as USD 1000 for hostel and fooding. Also the reduction in the boundaries of fee remission by 0.05 points on the prescribed CGPA has been ratified, considering first time admission at the Institute.

Item No. S/43/31 **Policy on engaging Guest faculty at NIT Agartala**

The SENATE perused the proposal and resolved the following in view of shortage of faculty members at the Institute:

(1)The rate of the honorarium for taking classes are approved as below:

- For Professor (in service/ retired) : Rs. 40,000/- for 1 credit course.
- For Asso. Professor (in service/ retired): Rs. 35,000/- for 1 credit course.
- For Asstt. Professor (in service/ retired): Rs. 30,000/- for 1 credit course.

iv. For personnel not in regular service (State Govt./ Central Govt.) : Rs. 25,000/- for 1 credit course.

(2) For each credit, a minimum number of 13 classes (one hour) is required to be conducted by the faculty member. The faculty member is required to conduct class test/ provide assignments, prepare question papers for Mid-term and End-term exams and evaluate answer scripts. The honorarium as mentioned above will include the transportation allowance, and no other expenses will be borne by the Institute.

(3) The payment of honorarium will be considered after completion of all the requirements such as examinations, evaluation of answer scripts.

(4) The lectures should be done in offline mode only. However, a maximum of one hour lecture may be taken through online mode in a week.

(5) The selection of such faculty will be for at least one semester. The concerned Academic Department will do the merit based selection and to be placed to the Director for approval with the proper justification and recommendation of the DUPC/ DPPC, through the Dean (AA).

(6) Personnel working in research organizations or retired from the Institutes / Industries can be considered for engagement on case to case basis, following the procedure in point no. (5) above.

Item No. S/43/32 **Consideration and approval of Introduction of one Elective courses titled "Electricity Market: Concepts and Operation" in the B.Tech programme and two Elective courses in M.Tech programme titled "Operation and Management of Deregulated Power System" and "Smart Grid Technology: Concepts and Applications" of Electrical Engineering Department.**

The SENATE approved and confirmed the introduction of following elective courses under the Electrical Engineering Department:

1. "Electricity Market: Concepts and Operation" in the B.Tech programme; and
2. "Operation and Management of Deregulated Power System" and "Smart Grid Technology: Concepts and Applications" in M.Tech programme.

This will be effective from the academic session 2024-25.

Item No. S/43/33 **Consideration and approval of inclusion of '5G Networks & Beyond' as Departmental Elective subject in the B.Tech (4th Year) curriculum of ECE Department.**
