NOTICE

In pursuance of the Notification dated 30th July, 2024 issued by the Under Secretary to the Government of Tripura (copy attached), General Administration (S.A) Department and based on the approval of the Competent Authority, NIT Agartala, the employees who are ordinarily a resident of the constituency and registered as an elector in the jurisdiction where General Election to Panchayats are going to be held are allowed to avail **Special Casual Leave on 8th August, 2024 (Thursday)**, to enable them to exercise their right of franchise.

Similarly casual/daily wages workers working at NIT Agartala but registered as an elector in the jurisdiction where General Election to Panchayats are going to be held, would be entitled to the **benefit of a paid Holiday on 08-08-2024** under Section 135B(I) of the Representation of the People Act. 1951

This shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he/she is engaged.

NOTIFICATION

In exercise of the powers conferred by the Section-135B of the Representation of the People Act, 1951, the Governor, Tripura is pleased to declare that all the Government Offices, Magisterial Courts, Educational Institutions, Financial Institutions and all other establishments shall remain closed on **8th August 2024 (Thursday)** falling within the jurisdiction where **General Election to Panchayats 2024** are going to be held, to enable the voters to exercise their right to franchise.

2. 8th August 2024 will also be a **paid holiday** for the employees of Industrial undertakings, all other establishments of the Government of Tripura coming under the purview of the factories Act, 1948 and daily rated/contingent employees under the Government of Tripura and workers/employees in any business/trade in Tripura posted under the jurisdiction where General Election to Panchayats are going to be held, to enable them to exercise their right to franchise on the poll day.

3. There may be cases where a person is ordinarily a resident of the constituency and registered as an elector in the jurisdiction where General Election to Panchayats are going to be held but serving/employed in Government Establishment or an Industrial Undertaking or other establishment located outside the said jurisdiction, in such cases, those electors are allowed to avail **Special Casual Leave** to cast their vote. Similarly, casual/daily wages workers working outside the said Panchayat Constituencies would be entitled to the benefit of a **paid holiday** on 08.08.2024 under Section 135B(1) of the Representation of the People Act, 1951.

4. This shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he/she is engaged.
