02	Senior Research Fellow(SRF): Qualification prescribed for JRF with two years of research experience	Ph.D	42,000/-	3years

As per the office memorandum, after the completion of two years, an external assessment by the Institution where the student is enrolled for Ph.D is mandatory for upgradation from JRF to SRF. The fellowship may be awarded to SRF after successful assessment of Ph.D scholar. Annual satisfactory assessment is mandatory to continue the benefit of fellowship. The enhanced rates of scholarship for Ph.D scholars will be effective from 01/01/2023.
