- Students applying for the scheme need to "Register" on the portal as fresh applicant, using the link "Citizen login" at BMS Portal URL https://bms.tripura.gov.in, by providing accurate and correct information as per their documents.
- > Before initiating registration process, students are advised to go through the user manual of the BMS Portal.
- > The student shall login in the portal using their Mobile No./email ID. After successful login student can apply in any one State Scheme on-boarded on BMS portal by providing required information.
- The students pursuing Degree/Master Degree/ Diploma in the Colleges/Institutions under the control of Higher Education, Government of Tripura should select their concerned Institution in the drop down box of the BMS portal and students studying beyond the Higher Education control institution shall select "Directorate of Higher Education" while applying application.
- > After successful submission of online application in BMS portal, the student shall submit the print copy of filled up online application with necessary documents to the concerned Institution/ Directorate of Higher Education, Shiksha Bhawan, Office lane, Agartala.



- The College/Institute Nodal officers shall approve student's application online in the portal after verifying the correctness of detail application submitted and uploaded documents required for availing the scheme.
