- 7) An **online provisional registration slip** will be generated. (Candidates must enable the pop-ups in their browser to download the online provisional registration slip)
- 8) All are instructed to save the provisional registration slip for future reference and bring the same in hard copy during physical reporting.
- 9) Candidates are instructed to complete the above mentioned procedure before appearing for physical reporting.
- 10) One set of photocopy of all documents duly self attested must be submitted during the physical reporting at the institute.
- 11) Candidates must bring all original documents for verification during physical reporting.
- 12) All candidates must submit **original migration and character certificate** during physical reporting.
- 13) Admission to PWD candidate is subject to verification by the Institute medical team.
- 14) Candidates under **Part-time / External Registration category need to mandatorily submit NOC / Sponsorship Certificate of External registration** in the prescribed format from the employer without which there will be no admission.


