



2. Bid received after the due date & time will not be considered.
3. Bid Security or EMD: 2% of the estimated cost of the tender or Bidders should submit "**Bid Security Declaration Form**" on company letter head as per annexure-B of this tender document.
4. Delivery Option: 10 (ten) days after receipt of the purchase/work order(s) at NIT Agartala campus (if required).
5. Bid should be valid for a period of **90** days from the opening date of the bid.
6. The bidders should quote their rates in clear terms without ambiguity. The quotation should be only in Indian Rupees.
7. Bid must be filled in legibly and overwriting/corrections, erasures etc. if any, must be duly attested, and **ON YOUR LETTERHEAD ONLY**.
8. Each bidder shall submit only one bid **against one enquiry**. A bidder, who submits more than one bid against single enquiry, shall be disqualified and considered non-responsive.
9. Accordingly preference will be given to the Make in India products while evaluating the bids, however, it is the sole responsibility of the bidder(s) to specify the product quoted by them is of Make in India product along with respective documentary evidence as stipulated in the aforesaid order in the technical bid itself. A self-declaration as per Annexure- C should be enclosed in the technical bid.
13. The rates shall quoted according to the units indicated in the enquiry letter and the rates preferably include all charges, taxes, duties etc. also these charges shall be shown distinctly and separately.
14. Conditional discount, if any, offered by the bidder shall not be considered at the time of evaluation
15. All rates should be based on delivery by the Supplier at National Institute of Technology, Agartala.
16. The exact delivery period and terms of delivery shall invariably be mentioned in the quotation.
17. **Payment: 100% will be made in INR (Indian National Rupees) after successful completion of the work and duly certified by the concerned authority. The quality of the work should be as per the specifications mentioned in the tender document. If any deviation found, NIT Agartala will not bound to make any payment.**
18. All payments due under the contract shall be paid after deduction of statutory levies at source (like ESIC, IT (TDS), GST, LBT / Octroi etc.), wherever applicable.
19. **An order for supply when placed, must be completed in full within the delivery period indicated on the order. Failure to supply or replace the rejected materials if any, will render the order liable to be cancelled without notice and the material will be procured elsewhere at your risks and cost.**
