ADMISSION NOTIFICATION

4-Year Integrated Teacher Education Program (ITEP) B.Sc.- B.Ed. (Secondary level) for the Academic Year 2025-26

I. Admission to B.Sc.- B.Ed. (Secondary level) 2025-26

Applications are invited for admission to the 4-Year Integrated Teacher Education Program (ITEP) B.Sc.-B.Ed. programme (Secondary level) at NIT Agartala for the Academic Year 2025-26, based on the NCET 2025 exam conducted by NTA.

II. Seat Distribution

Seat distribution for 4-Year ITEP B.Sc.- B.Ed. (Secondary level) for the Academic Year 2025-26 at National Institute of Technology Agartala is as follows (Total intake: 50):

III. Minimum Eligibility requirements:

a) The candidate should pass class XII Board Examination (10+2) or its equivalent examination securing minimum of 50% marks in aggregate (best five subjects, including Physics, Chemistry and Mathematics) from a recognized Board/Council.

And

b) To be eligible, it is mandatory that the candidate should have studied and passed Physics, Chemistry and Mathematics subjects in class XII Board Examination (10+2) or its equivalent examination.

And

c) The candidate should be qualified in NCET-2025, conducted by NTA. Must have appeared for the **Physics, Chemistry, and Mathematics** tests as the domain subjects in the NCET 2025 conducted by the National Testing Agency (NTA).

And

- d) State of eligibility (HS or OS):
 - i. State of eligibility means the state from where the candidate has passed Class XII (or equivalent) examination. It is to note that the state of eligibility <u>DOESNOT</u> depend upon the native place or the place of residence of the candidate.

- ii. If a candidate has passed Class XII (or equivalent) examination from one state but appeared for improvement from another state, the candidate's state of eligibility will be from where the candidate first passed the Class XII (or equivalent) examination and NOT the state from where the candidate has appeared for improvement.
- iii. For Open Schooling candidates, the state of centre will be considered as the State of Eligibility.

IV. Selection Procedure:


- i. Scrutiny of applications based on the number of available seats (category-wise) and eligible candidates in order of merit of the score obtained in the NCET-2025
- ii. Fulfilment of Minimum Eligibility requirements as per section III.
- iii. A merit list will be generated by NIT Agartala based on the score in NCET-2025 obtained.

Note:

- 1) In case of any tie, the candidate older in age will be placed above the candidate who is younger in age. If the tie breaking criterion fails to break the tie, then, higher marks in the total marks obtained in Mathematics, Physics and Chemistry papers in 12th/ Higher secondary level will be considered as tie-breaker.
- 2) In cases where a qualifying board issues only letter grades without providing the corresponding percentage of marks, the candidate must obtain and submit a certificate from the board indicating the equivalent percentage at the time of seat acceptance. In case of failure to provide such certificate, the decision of NIT Agartala will be final and binding.
- 3) Preference may be given to the candidates who has opted NIT Agartala while applying for NCET 2025.
- 4) Inclusion in the **NCET 2025 scores** does **not guarantee admission**. Admissions will be made **purely on merit**, based on NCET scores, and **subject to seat availability** at NIT Agartala.
- 5) All admission offers made during the seat allotment process shall be considered **provisional** until the candidate fulfils **all admission requirements and deadlines** as stipulated by NIT Agartala.

V. Online application:

- All applicants must apply online https://admission.nita.ac.in/
- The portal is compatible to Mozilla Firefox. Candidates are advised to use Mozilla Firefox browser only.
- Candidate should apply through online mode only. Requisite non-refundable application fee to the extent of Rs. 1000/- for OP/OBC-NCL/EWS candidates and Rs. 500/- for SC/ST/PwD candidates has to be submitted through the <u>online payment portal only</u>. <u>Offline hand written</u>, or printed application will not be entertained.

- After registration, Application ID (to be used as login name) with Password will be sent to the email ID provided by the applicant.
- Using the login credential, applicants must login to the Admission Portal for filling the required information.
- Application fees (non-refundable) must be paid through this online portal only.
- After completion and submission of the online form, filled in form in PDF format will be generated.
- On the day of reporting, candidates should bring a printed copy of the on-line filled-in form along with all the original of the necessary documents (to support all educational qualification, date of birth, category, NCET- 2025 score card etc.) and a set of photocopy of all such documents, duly self-attested.
- NIT Agartala will not be responsible for any failure on the part of the candidates in making payment of application fee online for any reason.

VI. Documents to be uploaded (Scanned copy of Original):

(Multiple documents to be converted into a Single PDF file and uploaded wherever applicable)

- 1. Valid score card of NCET-2025 (mandatory).
- 2. 10th standard/Matriculation or equivalent certificate or any other certificate issued by government authorities, as proof of Date of Birth and Name of Candidate (mandatory).
- 3. Mark sheet/grade card and Pass certificate (if issued separately from school) of the class XII Board examination (10+2) or its equivalent examination (As single PDF file) (mandatory).
- 4. For proof of State of eligibility:
 - Mark sheet/grade card and Pass certificate (if issued separately from school) of the class XII Board examination (10+2) or its equivalent examination (As single PDF file) in case name and address of school clearly written on it. In case of applicant passing from Open School, admit card of 12th examination (mandatory).
- 5. Conduct/Character Certificate issued by the Institution last attended.
- 6. SC/ST/PwD/OBC-NCL/EWS certificate (if and whichever applicable).

The <u>OBC-NCL/ EWS</u> certificate must be issued by Competent Authority <u>on or after 01/04/2025</u>. Admission under PwD category as per point no. e under important note and based on the recommendation of Medical Board of NIT Agartala.

Important Note:

- a) Caste certificate (SC/ST/OBC-NCL) issued by Maharashtra State must be validated by Social Welfare department (in case of SC and OBC-NCL category) and Tribal Welfare department (in case of ST category) of Maharashtra Government.
- b) SC/ST/OBC-NCL candidates of Maharashtra State have to produce their Caste Validity Certificate.

- c) ST certificates from Tamil Nadu state must be issued by the concerned Revenue Divisional Officer.
- d) If any Certificate is in a language other than English/Hindi, an English version of that certificate attested by a Gazetted Officer/Competent Authority should be uploaded compulsorily, along with scan copy of original certificate in a <u>Single PDF file</u>.
- e) *PWD candidates* seeking admission under the PwD category must submit a valid disability certificate (as per Annexure 2) or a Unique Disability Identification (UDID) certificate. Only candidates with benchmark disabilities (40% or more impairment), regardless of the type of disability, are eligible for reservation. The disability must be certified by a Government Medical Board, and the candidate must be deemed medically fit to pursue the programme. The certificate should preferably follow Form-PwD (II), Form-PwD (III), or Form-PwD (IV), as per the *Rights of Persons with Disabilities Rules*, 2017.
